<p>Violation #22. Cold holding temperatures Keep cold held foods at 41F or below. Observed hard boiled eggs on serving line cold holding plate; recorded inside temperature 58F. Observed ham and cheese sandwiches on serving line cold holding plate; recorded inside temperature 58F. Recommended PIC to use metal trays versus plastic trays to help with temperature holding. CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held cold, and not subject to an approved HACCP plan, must be maintained at 41°F.</p>
<p>Violation #47. Food & non-food contact surfaces Repair/replace out-of-order sigle-door Traulsen refrigerator.BPC#0817217. Work order in place. Repair/replace gas serving line hot well on far left. Per PIC hot well is not keeping food warm enough. BPC#09940002. Hot well hot water temperature was recorded at 114F. Repair/replace double-door Delfield freezer. Serial number#1109152001622. Per PIC unit is not keeping temperature. Inside temperature recorded at 4F. Work order #10092505 CODE REFERENCE: 64E-11.003(4). Equipment and utensils must be properly designed, constructed, and in good repair.</p>
<p>Violation #55. Facilities installed, maintained, & clean Repair/replace out-of-order dryer machine. Per PIC machine does not start.Work order#10090654. CODE REFERENCE: 64E-11.003(5). Floors, walls, and ceilings shall be smooth, durable, easily cleanable, and non-absorbent. Exterior areas shall be kept cleaned.</p>
<p>Violation #56. Ventilation & lighting Replace broken ceiling light cover in the 3-compartment sink area. CODE REFERENCE: 64E-11.003(6)(a). Adequate exhaust ventilation hood systems in food prep and warewashing areas shall be provided and designed. 50 foot candles shall be at surfaces where employees work with food and 20 foot candles shall be at surfaces where food is provided to consumers.</p>
